


What is CBA?

 - the scenes work


- What is the evaluator's role?

What is the CBA Program?

Goal-oriented:

- To build our clients' capacity to provide HIV/AIDS prevention interventions
 - Broad spectrum of knowledge, skills, & attitudes are targeted by CBA services

Multi-faceted:

- Various types of clients
- Multiple service delivery mechanisms
- Different avenues by which a project is initiated

National in scope:

- 32 Capacity Building Assistance provider organizations
- Services are available to organizations directly or indirectly funded by the CDC



M&E Challenges

Goal-oriented program – goal-oriented evaluation

- How to operationalize capacity? How do we know if it's been built?
- How to determine if services have had an effect on disease incidence? On people at risk or living with HIV/AIDS?

Multi-faceted program – multi-faceted evaluation design

How to design a rigorous, cohesive evaluation plan for a program with so many components

Compartmentalization of Roles

- Many of us are CBA providers as well as program evaluators; how to maintain healthy objectivity?
- How to navigate complex relationships with stakeholders?
