TIG MEMBER SURVEY RESULTS



In November 2018, the NPF TIG sent its members a survey. Of about 1290 people who received the survey, 69 NPF TIG Members responded (response rate of 5.3%).

CHARACTERISTICS OF RESPONDENTS

Respondents primarily worked for Nonprofits (36.2%), Evaluation Firms (30.4%), and Foundations (21.7%). Other types of organizations included:

- University
- Research Consulting
- Nonprofit & Grantmaker
- Consultant



FEEDBACK ON THE BUSINESS MEETING AT THE 2018 CONFERENCE

Respondents identified networking, and Efrain Gutierrez's (of the Obama Foundation) presentation as the most valuable aspects of the business meeting.

Suggestions for improving the meeting included:

- Having a more structured agenda
- Making better use of time
- Having clearer documentation of the business part of the meeting
- Sending follow-up documents to the TIG members
- Making the presentation more actionable

BUSINESS MEETING AT THE 2019 CONFERENCE

Almost half of respondents (45.8%) were most interested in having the 2019 Business Meeting be a networking session. Others were interested in an expert panel (20.3%) or presentation (18.6%).
